Our exchange services are an intelligent way to buy a vehicle of any kind without giving a large sum directly to a seller. By using our exchange services you are doing all you can do to make this purchase a safe and satisfactory experience for yourself.

The documents included in this packet are as follows and here is what you need to do to start the process:

- 1. Intro Page (This Page): Fill out payment info (if paying by Credit card) and return with signature
- 2. Easy Account Set Up Form please complete and return
- 3. A Frequently Asked Questions Page do not return
- 4. An Explanation of The Process do not return
- 5. Our Exchange Service Terms and Conditions do not return

Our Exchange Services cost \$200. You may pay by check, by wire or credit card. After reading the Terms of Service please sign below. Don't forget to send the account set up form with this page and payment for the service fee if not by credit card. You may deposit funds into the escrow account by sending a separate check made out in the seller's name, or by wire transfer.

The Exchange Service Process

- **Step 1.** Buyer or Seller completes the Account Set Up Form with payment and sign that the Terms of Service have been read. This is usually the buyer.
- **Step 2.** Once the Set Up form has been received, the seller will receive from CCG information about the service (assuming the buyer initiated the service), explaining the procedure. FYI, It often works better if we explain it than if buyers try and explain it.
- **Step 3.** Buyer and seller sends the following items below to our office.
 - Buyer: Sends funds for vehicle plus CCG Exchange Service fee of \$200 (assuming buyer is paying for exchange services) to CCG.
 - Seller: Sends Title with signature of release and Bill of Sale to CCG.

Step 4. CCG contacts buyer and seller. Each party must agree that documentation is correct. Upon agreement, CCG will send the buyer the completed Title and Bill of Sale and send the seller the funds for the automobile.

The process can take a day or two to complete and depends mostly on the prompt sending of information such as the title, checks, etc. to Classic Car Guy

Classic Car Guy - Terms of Service



These Terms of Service shall serve as an agreement that sets forth the terms and conditions. If you agree to these Terms of Service, you will be bound as follows:

Description of the Service

Classic Car Guy Exchange service provides a safe way for the buyer and seller to exchange money for a title during the purchase of a vehicle.

Limits on the Services

Any vehicle(s) purchased from classified ads, etc. are eligible. Our Service may not be used for the purchase of real estate or other non-transportable items. Also, our service may not be used to purchase any items, which are prohibited by law. If you have something that you are unsure if it qualifies for use of our services, please feel free to email us at info@ClassicCarGuy.com and ask.

Prohibited Transactions

Any fraudulent transactions are prohibited.

General Conditions of Use

Anyone or company may use our services.

Obligations of Sellers

The obligation of the seller is to provide a signed off title and bill of sale to Classic Car Guy in order to receive payment for specified vehicle. Sellers should communicate the method of payment acceptable for the transaction to the buyer ASAP in the process.

Obligations of Buyers

The obligation of the buyer is to provide a valid method of payment to Classic Car Guy for the purchase of the vehicle. The sellers generally dictate this method of payment.

Our Responsibilities

Classic Car Guy is responsible for providing a holding service. We cannot be held liable for any issues that do not pertain to the actual holding service we provide.

Canceling A Transaction

You are free to cancel a transaction at any time before the transaction is considered completed in our offices(typically, after mailing the final documents). You will not be refunded the service fee if cancellation were to take place after this time.

Service Fees

All fees are due before transaction is complete. The seller and buyer can agree on who pays the service fee, although the buyer typically pays it. The service fee will be a separate check or credit card charge sent to Classic Car Guy along with the funds sent to Classic Car Guy by the buyer. The fee for our service is \$200.00.

Termination of Services

We may suspend or terminate your use of the Services at any time. This will be done with notice to all the customers involved in the transaction.

Title Information

Classic Car Guy cannot be held liable for titles that are marred, changed, or in any other way to make the title void. We do not alter the title in any way. It is the seller's responsibility to make sure the title is accurate before sending the title to Classic Car Guy. It is the buyer's responsibility to contact the seller if the title, for any reason, is not accurate enough to process though your local license bureau. Classic Car Guy's only responsibility concerning title information is to relay to the buyer the Year, Make, Model, Color, and VIN# that is found on the front side of the vehicle's title. On request, we will fax a copy of the completed title to the buyer for title accuracy inspection.

Payment Cancellation

Classic Car Guy cannot be held liable for cashier checks, money orders, or any other method of payment that is cancelled before the seller receives the item of payment. The seller must seek legal advice concerning this legal issue. The seller must pursue legal action against the buyer, not Classic Car Guy.

Miscellaneous

In the event of any dispute, claim, question, or disagreement arising from or relating to, this Agreement or to the Underlying Transaction, or breach of any of them, you agree to resolve such dispute in the manner set forth in these Instructions. This Agreement shall be governed by the laws of the State of California, San Luis Obispo County.

Frequently Asked Questions

Q. Who pays the service fee to Classic Car Guy?

A. The seller and buyer can agree on who pays the service fee, although the buyer typically pays it. The service fee will be a separate check or credit card charge sent to Classic Car Guy along with the funds sent to Classic Car Guy by the buyer. The fee for our service is \$200.00

Q. Can anyone use Classic Car Guy's services?

A. Yes, anyone can use Classic Car Guy services. Any vehicle(s) purchased from classified ads, etc. are eligible. Classic Car Guy exchange services may not be used for the purchase of real estate or other non-transportable items. Also, Classic Car Guy exchange service may not be used to purchase any items, which are prohibited by law. Q. Who do I make the money order or personal check out to?

A. Make payments out to the following:

- 1. Please make the purchasing vehicle(s) funds check out to the seller's name.
- 2. Please make the service fee check for \$200.00 out to Classic Car Guy.

Q. What are my payment options?

A. You can use the below methods:

- 1. When purchasing the vehicle, the funds are specified by the seller.
- 2. Our Service Fee: Visa, MasterCard, American Express, Cashier's Check, Business Check, Certified Check, Money Order, Pay Pal, or Wire Transfer.

Q. Why should I use Classic Car Guy's Exchange services?

A. Classic Car Guy provides a low cost, easy to use form of insurance to make your transaction with other people a safe and easy. It takes the trust issue out of the transaction and helps prevent fraudulent sales.

Q. How long will the process take?

A. The normal escrow process takes approx. 3-5 days. We are open 8:00am to 5:00 pm Pacific Standard time, 5 days a week. The normal escrow time also depends on the prompt sending of information such as the title, checks, etc. to Classic Car Guy.
